Detailed Regulations Pertaining to Scope of National University Corporation the University of Osaka Administrative Posts

Note: The document below is an English translation of the University Work Regulations, originally composed in Japanese. The English version of the Work Regulations has been provided merely as a reference for international researchers and employees. Therefore, it should not be considered an official employment contract. Please note that any and all official employment contracts are concluded solely on the basis of the Japanese version of the Work Regulations.

#### (Purpose)

Article 1: The purpose of these detailed regulations shall be to define the scope of administrative posts in accordance with the provisions of Paragraph 2 and Paragraph 6, Article 25 of The Salary Regulations for National University Corporation the University of Osaka Staff, Paragraph 2 and Paragraph 6, Article 13 of The Salary Regulations for National University Corporation the University of Osaka Staff Subject to Annual Salary System, Paragraph 2 and Paragraph 6, Article 22 of The Salary Regulations for National University Corporation the University of Osaka Staff Subject to New Annual Salary System, Paragraph 2 and Paragraph 6, Article 24 of The Salary Regulations for National University Corporation the University of Osaka Limited Term Staff, Paragraph 2 and Paragraph 6, Article 14 of The Salary Regulations for National University Corporation the University of Osaka Limited Term Staff Subject to Annual Salary System, and Paragraph 2 and Paragraph 6, Article 21 of The Salary Regulations for National University Corporation the University Corporation Staff Subject to New Annual Salary System.

## (Scope of Administrative Posts)

- Article 2: The scope of administrative posts and the classification of duties for those holding such posts shall be in accordance with Appendix-1. For those holding multiple administrative posts, classification of duties for which the greatest amount of Administrative Post Allowance shall be applied.
- The scope of administrative posts and the classification of duties for those holding such posts set forth in Appendix-1 shall be subject to change due to corporate reorganization etc., and in consideration of the financial condition of the University.

The foregoing detailed regulations shall be implemented from 14 April, 2004 and applied from 1 April, 2004.
