Special Regulations Pertaining to the Salary and Retirement Allowance for National University Corporation the University of Osaka Special Case Staff

Note: The document below is an English translation of the University Work Regulations, originally composed in Japanese. The English version of the Work Regulations has been provided merely as a reference for international researchers and employees. Therefore, it should not be considered an official employment contract. Please note that any and all official employment contracts are concluded solely on the basis of the Japanese version of the Work Regulations.

(Purpose, etc.)

- Article 1: The purpose of these regulations is to define the special regulations of the Salary Regulations for National University Corporation the University of Osaka Staff (hereinafter referred to as "The Salary Regulations"), The Salary Regulations for National University Corporation the University of Osaka Staff Subject to New Annual Salary System (hereinafter referred to as "The Salary Regulations for Staff Subject to New Annual Salary System"), The Salary Regulations for National University of Osaka Limited Term Staff (hereinafter referred to as "The Salary Regulations for Limited Term Staff Subject to New Annual Salary System (hereinafter referred to as "The Salary Regulations for Limited Term Staff Subject to New Annual Salary System (hereinafter referred to as "The Salary Regulations for Limited Term Staff Subject to New Annual Salary System"), and the Regulations Pertaining to Retirement Allowance for National University Corporation the University of Osaka Staff and the Regulations Pertaining to Retirement Allowance for National University Corporation the University of Osaka Limited Term Staff (hereinafter collectively referred to as "The Retirement Allowance Regulations"), with respect to Special Case Staff as defined in the following Paragraph.
- 2. Under these regulations, "Special Case Staff" means full-time Academic Staff, Researcher (limited to Academic Policy Researcher), Administrative Staff, Technical Staff, Technical Staff (Medical), Technical Staff (Nursing), Technician (limited to the Assistant Nurse who is affiliated with the University of Osaka Hospital), staff who has not yet acquired a license (meaning an individual who is employed prior to the acquisition of the license required to engage in the duties as a Technical Staff (Medical) or Technical Staff (Nursing) and Senior Administrative Staff, Senior Technical Staff, Senior Technical Staff (Medical), Senior Technical Staff (Nursing) and Senior Technician (limited to the Assistant Nurse who is affiliated with the University of Osaka Hospital) (hereinafter referred to as "Senior Staff"); hereinafter the same shall apply) of National University Corporation the University of Osaka (hereinafter referred to as "The University"), who shall receive a Special Bonus in place of a Retirement Allowance.

(Non-Payment of Retirement Allowance)

Article 2: The Retirement Allowance Regulations shall not apply to Special Case Staff.

2. The status of a Special Case Staff shall not be changed to the status of a staff to whom the Retirement Allowance Regulations applies, except for staff specially deemed necessary by The University.

(Payment of Special Bonus)

- Article 3: A Special Bonus shall be paid to a Special Case Staff in each bonus payment period, in the amount indicated in the Appendix corresponding Basic Salary Table, Work Class or Work Classification applies to Special Case Staff (in the case of any class exceeding the work classes for which Special Bonus amounts are indicated in the same Appendix, the amount shall be determined in each case); provided, however, if a Special Case Staff falls under any of the following categories, the payable Special Bonus shall be increased or reduced corresponding to the number of months of continuous service as a Special Case Staff.
 - (1) An individual whose number of months of continuous service during the six-month period prior to and including the month of the standard day (June or December) for the bonus payment of the current period is less than six months, or an individual who retired during the same six-month period.
 - (2) An individual who is recruited, etc., in the month of the standard day for the bonus payment of the previous period [limited to the case in which the individual is recruited, etc., on or after the date (2 June or 2 December) following such standard day].
- 2. Notwithstanding the provision of the preceding Paragraph, the Special Bonus shall be paid to the retired individual described in the latter part of No. 1 of the proviso of the same Paragraph, within one month following the retirement.

- 3. In addition to the provisions of the preceding 2 Paragraphs , the provisions of Paragraph 2 and 3, Article 20 of The Salary Regulations, the provisions of Paragraphs 2 and 3, Article 20 of The Salary Regulations for Staff Subject to New Annual Salary System, Paragraphs 2 and 3, Article 19 of The Salary Regulations for Limited Term Staff, and Paragraphs 2 and 3, Article 19 of The Salary Regulations for Limited Term Staff Subject to New Annual Salary System shall apply mutatis mutandis to the payment of the Special Bonus. In this case, "Employees who, within the period from a standard day to the day of payment, are ...The Work Regulations" as described in Item 3, Paragraph 2 of each of the Articles shall be read as "Employees who are...The Work Regulations."
- 4. The amount of the Special Bonus shall be amended considering the situation of the amendment of salary and Retirement Allowance of government employees, etc., and the financial conditions of The University.

- (Interim Measure Pertaining to Amount of Special Bonus)
- 2. Notwithstanding the provision of Paragraph 1, Article 3, "the amount indicated in the Appendix" as described in the same paragraph shall be read as "the amount indicated in the Provisional Appendix" up until 30 June 2014.
