Rules Pertaining to Types of Work Regulations Created by National University Corporation Osaka University and Staff to whom Regulations Apply

Note: The document below is an English translation of the University Work Regulations, originally composed in Japanese. The English version of the Work Regulations has been provided merely as a reference for international researchers and employees. Therefore, it should not be considered an official employment contract. Please note that any and all official employment contracts are concluded solely on the basis of the Japanese version of the Work Regulations.

## (Purpose)

Article 1: The purpose of these rules shall be to define regulations created by National University Corporation Osaka University (hereinafter referred to as "The University") and employee to whom said regulations apply.

(Types of Work Regulations and Employee to whom Regulations Apply)

Article 2: Types of work regulations created by The University and the job titles of teaching staff or other staff to whom such regulations apply are listed hereunder.
