

Rules Pertaining to Types of Work Regulations Created by National University Corporation Osaka University and Staff to which Regulations Apply

Note: The document below is an English translation of the University Work Regulations, originally composed in Japanese. The English version of the Work Regulations has been provided merely as a reference for international researchers and employees. Therefore, it should not be considered an official employment contract. Please note that any official employment contracts have been concluded solely on the basis of the Japanese version of the Work Regulations.

(Purpose)

Article 1: The purpose of these rules shall be to define regulations created by National University Corporation Osaka University (hereinafter referred to as "The University") and staff to which said regulations apply.

(Types of Work Regulations and Staff to which Regulations Apply)

Article 2: Types of work regulations created by The University and the job titles of teaching staff or other staff to which such regulations apply are listed hereunder.

Work regulations for National University Corporation Osaka University Limited Term Staff	University teachers, researchers, administrative staff, technical staff, technical staff (medical), technical staff (nursing), technicians, laborers, educational supporting employees
Work regulations for National University Corporation Osaka University Limited Term Commissioned Staff, Etc.	Commissioned staff, special commissioned staff
Work regulations for National University Corporation Osaka University Part-time Staff(Temporary Full-time Staff)	Assistant administrative staff, assistant technical staff, assistant technical staff (medical), assistant technical staff (nursing), assistant technicians, assistant laborers, assistant educational affairs office employees
Work regulations for National University Corporation Osaka University Part-time Staff(Temporary Part-time Staff)	Assistant administrative staff, assistant technical staff, assistant technical staff (medical), assistant technical staff (nursing), assistant technicians, assistant laborers, assistant educational affairs office employees
Work regulations for National University Corporation Osaka University Part-time Staff(Temporary Full-time Education and Research Staff)	Specially appointed University teachers, specially appointed researchers, residents, junior residents
Work regulations for National University Corporation Osaka University Part-time Staff(Temporary Part-time Education and Research Staff)	Specially appointed University teachers, specially appointed researchers, residents, junior residents

Supplementary Provision

(Date of Implementation, etc.)

1. The foregoing regulations shall be implemented from 14th April 2004 and applied from 1st April 2004.

Supplementary Provision

The foregoing amendments shall be implemented from 1st April 2005.

Supplementary Provision

The foregoing amendments shall be implemented from 1st April 2007.

The foregoing amendments shall be implemented from 1st April 2009.
