

Operation and Management Responsibilities of Public Research Funds at Osaka University

Chief Executive Officer	President of the University
(Excerpts from National University Corporation Osaka University Regulations Pertaining to Public Research Funds) Article 4. The University shall establish the post of Chief Executive Officer to assume overall responsibility for the administration and management of Public Research Funds, and shall appoint the President of the University to the post.	
General Operating Officer	Executive Director designated by the President
Article 5. The University shall establish the post of General Operating Officer to assist the Chief Executive Officer with the substantial responsibility and authority to supervise the administration and management of Public Research Funds across the University, and shall appoint the Executive Director designated by the President to the post.	
Department Operating Officers	Head of each Department and Office (and the Executive Director in charge of finance in cases involving the Administration Bureau)
Article 6. The University shall establish the post of Department Operating Officer with the substantial responsibility and authority for the administration and management of Public Research Funds at the Departments and Offices of the University (including the Administration Bureau; the same shall apply to the rest of this Article), and shall appoint the head of each Department and Office (and the Executive Director in charge of finance in cases involving the Administration Bureau) to the post.
