

SNU Law Global Challenge Visiting Scholar Program

1. SNU Law Global Challenge Visiting Scholar Program

- As part of the SNU Law Global Challenge Project, this program offers foreign faculty members an opportunity to undertake 2 months of study and research at Seoul National University School of Law.
- Selected scholars are provided with round-trip airfare and living expenses while at SNU Law. Selected scholars are required to make at least one academic presentation in English on their proposed research project during their stay at SNU Law. Selected scholars are required to present at least one paper in English on their proposed research project within a month after the invitation period.

2. Application Qualifications

- Full-time Professor(at least a full-time lecturer) of a foreign university
- 2 applicants are chosen per semester

<Unqualified Application>

- When an applicant receives other grants for the same uses(airfare, living expenses, etc.) from other agency or organization
- When an applicant fails to submit a required paper after completing a previous fellowship project sponsored by SNU

- Invitation period: 2 months

* These conditions can vary depending on the time of year.

3. Coverage of the Scholarships

- Round-trip airfare and a stipend
 - Airfare: Round-trip economy class(by the most economical and direct route from the city of the selected scholar's home institution to Korea)
 - A stipend for 2 months: \$5,800(a amount of \$3,400 will be deducted from the stipend of \$ 5,800 for accommodation for single occupancy.)
 - Time of payment: At the end of the invitation period
- Selected scholars will be granted accommodation at SNU Hoam Faculty House (<http://www.hoam.ac.kr/eng/>) and full library access. Depending on availability, selected scholars may be given a shared office space equipped with a computer, internet connection and a telephone line. Selected scholars will also be invited to all seminars and events held at SNU Law.

4. Application Procedure

- Deadline for application
 - 2015 Fall semester: Pick 2 months during 2015.09.01.~2016.02.28. **[Deadline:2015.05.01.(Fri)]**
 - 2016 Spring semester: Pick 2 months during 2016.03.01.~2016.08.31. **[Deadline:2015.10.30.(Fri)]**
- Required documents: SNU Law Global Challenge Visiting Scholar Application[Form 1] and CV(including publications list)
- Submission: interlaw@snu.ac.kr / 02-880-6866
- Applicants will be notified within four weeks after the application deadline. If accepted as SNU Law Global Challenge Visiting Scholar, the candidate will receive a formal notification email from SNU Law.

5. Submission of Paper(Mandatory)

- Submission deadline: Within a month after the invitation period
- Required documents: Paper in English on proposed research project

6. Additional Notes

- Selected scholars are also advised to arrange for their own insurance prior to arrival. Medical, hospitalisation, dental and travel insurance coverage are not included in the appointment. Each scholar will be responsible for arranging the necessary visa.
